

Privacy Policy



Your privacy is important to Tulsa Area Triathletes. We want you to feel as comfortable as possible visiting our web site and using its services. By visiting tatok.com, you are accepting the practices described in the Privacy Policy.

We urge you to read our Privacy Policy so that you will understand what information we collect, how we protect it and what choices you have about how that information is used. This Privacy Policy does not apply to any information that you publish in a public forum (i.e. social media, chat rooms, events, etc.).

Personal Information We Collect

We collect information in distinct areas:

(1) Member information. We collect information necessary to establish and maintain your membership in accordance with USAT guidelines such as contact information, emergency contact information, age, gender, etc.

(2) We also collect information that you voluntarily provide to us through responses to surveys, questionnaires and the like.

(3) We may also collect information about you and your use of our site through the use of "Cookies". "Cookies" are small computer files that we create on your computer's hard drive through your web browser that allow us to know how often our site is visited, how often a user visits and the activities that are conducted while on our site (such as which chat rooms were visited, etc.). This information helps us dynamically generate advertising and content on web pages specifically designed for you and also allows us to statistically monitor how many people are using our site and for what purpose. Each individual user may disable cookies on their own machine. You may wish to explore the HELP file in your browser for more information. Sponsors and advertisers may also use Cookies when you select their advertisement; we are unable to control the use of Cookies by the sponsors or advertisers or how they manage the information they gather.

Disclosure of Your Information

Except as set forth in this paragraph, Tulsa Area Triathletes will not disclose to unaffiliated companies any information gathered from you which could be used to identify or contact you ("Personal Information"). Any Personal Information provided to entities affiliated with Tulsa Area Triathletes will be treated in accordance with the terms of this Privacy Policy, unless you are otherwise notified. In the following limited circumstances we may release, Personal Information to third parties: (1) to comply with valid legal requirements such as a law, regulation, search warrant, subpoena or court order; or (2) in special cases, such as a physical threat to you or others. We also provide Personal Information to our vendors and suppliers where it is necessary for them to provide us with products and services related to better operation and maintenance of our website ("Vendors"). We will attempt to require that each of

these Vendors not further use or disclose your Personal Information for any purpose other than providing us or you with products and services. Of course, we cannot guarantee their compliance with these restrictions.

Tulsa Area Triathletes may provide information about you, which does not allow you to be identified or contacted (“Aggregate Information”) to third parties. For example, we might inform third parties regarding the number of users of our site and the activities they conduct while on our site. We might also inform a manufacturing company (that may or may not be an advertiser on our site) that “30% of our users live in the Tulsa Metro area” or that “25% of our users have tried a certain product or service.” Depending on the circumstances, we may or may not charge for this information.

How Internal Privacy is Handled

Tulsa Area Triathletes wants your personal information to remain as secure as reasonably possible. That is why we use a third-party web services provider to provide these technical safeguards. All Tulsa Area Triathlete board members and volunteers are informed of this privacy policy and have acknowledged that they must abide by our Privacy Policy and that those who violate our Privacy Policy are subject to disciplinary action, up to and including legal prosecution.

Your Privacy Choices

When you complete a registration or similar interaction, you are opting-in to ongoing two-way communications with Tulsa Area Triathletes. You may opt out of receiving these emails by contacting the president of Tulsa Area Triathletes directly and requesting to be removed from correspondence. It is your responsibility to include all email addresses, phone numbers or other communication vehicles that you are requesting Tulsa Area Triathletes no longer communicate with you through. We ask for contact information (such as name and email address) if you wish to subscribe to various newsletters. You can unsubscribe from such newsletters very easily. When you have received a newsletter you wish to stop, click on the “update my preferences” button located in the Tulsa Area Triathletes newsletter, and follow the instructions for unsubscribing. Tulsa Area Triathletes will unsubscribe you from that newsletter as quickly as possible. If you opt-into the Tulsa Area Triathletes subscriber list via a ‘forwarded’ email account, it is your responsibility to unsubscribe using the original email address that you opt-into the Tulsa Area Triathletes subscriber list with. The Tulsa Area Triathletes site may contain links to other sites. Please be aware that Tulsa Area Triathletes is not responsible for the privacy practices of such other sites. We encourage you to read the privacy statements of each and every web site that collects personal information from you.
